	A Black Cockatoo Management Plan was approved by the department in October 2014. As per the requirements of both the interim (EPBC 2011/6192) and Life of Mine approvals (EPBC 2012/6370) NBG continues to implement management activities in accordance with the approved management plan.
4. To offset the loss of up to 29ha of suitable habitat for the EPBC listed Baudin's Black Cockatoo, Carnaby's Black Cockatoo and Forest Red-tailed Black Cockatoo, the person taking the action must register a legally binding conservation covenant over a conservation offset area within five years of the date of this approval. The covenant must provide protection for no less than 90ha of contiguous Jarrah-Marri-Wandoo forest suitable for Black Cockatoo foraging and breeding, and include at least 12 known or potential breeding hollows.	Within offset planning for the NBG LOM Extension Project (EPBC 2012/6370) considerations were made for inclusion of the 90ha offset within the proposed conservation covenant area. However, NBG is progressing discussions with DotEE fora variation to conditions that would see the proposed conservation covenant over native vegetation associated with EPBC 2012/6370 delayed until Phase 1 clearing has been completed (and the covenant would form the offset for Phase 2). Therefore, NBG is pursuing another option to satisfy Condition 4 of EPBC 2011/6192. The native vegetation in question is located on Hotham Farm, adjacent to vegetation currently in the process of being divested to the State Conservation Estate (as per Ministerial Statement 971). The area is approximately 190 ha in size. The vegetation has undergone assessment by an independent consultant and is rated primarily in excellent condition with a small section deemed very good and a small borrow pit that is rated as degraded. NBG will conduct restoration works in borrow pit area.
