### Bridging the Digital Divide – A focus from the start

## TDS was founded with the mission to provide outstanding communications services to our customers, especially in rural America.

As a controlled company, TDS and UScellular have a long-term investment horizon that has enabled the company to make long-term investments to bring communications services to under- and unserved communities.

- Recipient of significant Universal Service Funds, including Eligible Telecommunications
  Carrier (at UScellular) and A-CAM (at TDS Telecom)
- Will aggressively pursue funding of connectivity programs under the IIJA/BEAD program
- Serving rural America is more expensive!! TDS willing to accept the cost challenge.



### Corporate Governance Practice Highlights

- Annual election of all directors
- Annual "Say on Pay" vote
- Policy prohibiting pledging and hedging of company shares
- Charter and bylaws can be amended by a simple majority vote
- Authority of each committee to retain independent advisors
- TDS has established a Corporate Governance and Nominating Committee and Compensation and Human Resources Committee even though, as a controlled company, TDS is not required to do so
- Committee Charters have been expanded to include oversight of key ESG issues
- The positions of (i) Chairman of the Board and (ii) President and Chief Executive Officer are separate
- A Technology Advisory Group Committee enhances director understanding of technology matters impacting the company's future



### Well-Functioning Board of Directors

- · Board discussions are open, frank and substantive
- Engaged Board, taking decisive action as needed
- Annual self-assessment to identify opportunities for continuous improvement
- Independent directors work collaboratively and constructively with controlling shareholder
- Controlling shareholder values industry expertise and institutional knowledge
- Independent directors meet in private sessions regularly
- Independent directors may engage separate counsel
- Ongoing commitment to Board education including participation in NACD programs including ESG and cybersecurity
- Coaching developed a one-on-one mentorship program between board members and officerlevel executives

### TDS' Philosophy on Board Composition and Refreshment

- TDS Independent directors bring a valuable mix of skills
- TDS has placed significant emphasis on Board refreshment over the past several years
  - Goal bringing fresh and relevant experience and perspectives while retaining key expertise and institutional knowledge
- TDS believes that a well-functioning board should have a mix of short, medium and long tenured directors
- TDS has added four new directors in the past 5 years which, not including the four trustees of the Voting Trust, has held average tenure of the Board at ten years since 2018
- TDS believes it is appropriate to exclude the Voting Trust director tenure from the calculation of average Board tenure in light of the controlled company status.


## George W. Off, who has the longest Independent tenure, provides invaluable experience to the TDS Board
