**14** Describe the organizational action and, if applicable, the date of the action or the date against which shareholders' ownership is measured for the action ▶ Kinder Morgan, Inc. distributed cash to holders of its common stock on February 16, 2021 (\$0.2625 per share), May 17, 2021 (\$0.2700 per share), and August 16, 2021 (\$0.2700 per share). Kinder Morgan, Inc.'s 2021 earnings and profits are insufficient to characterize all of the 2021 distributions as qualified dividends. A portion of Kinder Morgan, Inc.'s dividends paid in 2021 are a return of capital for U.S. tax purposes.

**15** Describe the quantitative effect of the organizational action on the basis of the security in the hands of a U.S. taxpayer as an adjustment per share or as a percentage of old basis ▶ Based on information available at the time of this posting, a portion of the distributions made during 2021 are a non-dividend distribution and treated as a return of capital. A return of capital will be applied against the shareholder's basis under Internal Revenue Code 301(c)(2).

The part of the distribution that exceeds current and accumulated earnings and profits is treated as a non-taxable return of capital which reduces the shareholder's adjusted basis in the stock. If the distribution exceeds the stock basis, the excess is treated as capital gain.
