("**RME**") (TSX:RME), Canada's largest agriculture equipment dealer, today announced that as part of its ongoing efforts to rationalize its cost structure, it has initiated proceedings to voluntarily delist the common shares of RME from the OTCQX International marketplace ("OTCQX"). RME expects that the last trading day of its common shares on the OTCQX will be on or about December 31, 2019.

The common shares of RME will continue to trade on the Toronto Stock Exchange under the symbol "RME".
