As North America President for Mars, Gamgort led the nearly \$10B portfolio of snack food, pet food, pet hospital, retail, and main meal divisions. Gamgort joined Mars from Major League Baseball where he had been the President of Major League Baseball Properties -- the league's business and marketing arm. He started his career at General Foods, which later merged with and became Kraft Foods.

Gamgort holds an MBA in Marketing and Finance from Northwestern University's Kellogg School of Management, a BA in Economics from Bucknell University and studied at the London School of Economics.
