Ring Energy, Inc. Announces Pricing of Public Offering of Common Stock

MIDLAND, Texas--(BUSINESS WIRE ^[1])--Ring Energy, Inc. (NYSE MKT: REI) (the "Company") announced today that it has priced an underwritten public offering of 4,500,000 shares of its common stock to the public at \$12.50 per share. The Company has granted the underwriters a 30-day option to purchase up to an additional 675,000 shares of common stock from the Company at the offering price (less the underwriting discounts and commissions). The Company expects to close the sale of the shares of common stock on July 21, 2017, subject to customary closing conditions. Net proceeds to the Company from the sale of 4,500,000 shares will be approximately \$53.5 million, after deducting underwriting discounts, commissions and estimated offering expenses.

The Company intends to use the net proceeds from the offering to fund its 2017 capital expenditure program and for other general corporate purposes.

SunTrust Robinson Humphrey, Inc. and Seaport Global Securities LLC are acting as joint book-running managers in the offering. Capital One Securities, Inc., Euro Pacific Capital Inc., IBERIA Capital Partners L.L.C., Ladenburg Thalmann & Co. Inc., Northland Securities, Inc., and Roth Capital Partners are acting as co-managers.

The public offering is being made only by means of a prospectus supplement and accompanying base prospectus to a shelf registration statement previously filed with and declared effective by the Securities and Exchange Commission (the "SEC"). A preliminary prospectus supplement and accompanying base prospectus relating to the offering was filed with the SEC on July 17, 2017. A final prospectus supplement and accompanying base prospectus relating to the offering will be filed with the SEC.
