Ring Energy, Inc. Announces Pricing of Public Offering of Common Stock

MIDLAND, Texas--([BUSINESS WIRE](#) ^[1])--Ring Energy, Inc. (NYSE MKT: REI) (the "Company") announced today that it has priced an underwritten public offering of 10,000,000 shares of its common stock to the public at \$5.60 per share. The Company has granted the underwriters a 30-day option to purchase up to an additional 1,500,000 shares of common stock from the Company at the offering price (less the underwriting discounts and commissions). The Company expects to close the sale of the shares of common stock on April 26, 2016, subject to customary closing conditions. Net proceeds to the Company from the sale of 10,000,000 shares will be approximately \$53 million, after deducting underwriting discounts, commissions and estimated offering expenses. The Company intends to use the net proceeds from this offering to fund a pilot horizontal drilling program, repay debt under its revolving credit facility, and for general corporate purposes.

SunTrust Robinson Humphrey, Inc. and Seaport Global Securities LLC are acting as joint book-running managers in the offering.

The public offering is being made only by means of a prospectus supplement and accompanying base prospectus to a shelf registration statement previously filed with and declared effective by the Securities and Exchange Commission (the "SEC"). A preliminary prospectus supplement and accompanying base prospectus relating to the offering was filed with the SEC on April 20, 2016. A final prospectus supplement and accompanying base prospectus relating to the offering will be filed with the SEC.
